Such sheriff shall have such qualifications and duties as provided by law. The time of voting for the office of sheriff may be provided for by the legislature pursuant to section 18 of article 2 of this constitution.</p>

<p align="center">CONSTITUTIONAL AMENDMENT 1 Vote Yes or No</p> <p>To vote in favor of any question submitted upon this ballot, darken the oval to the left of the word "Yes." To vote against any question submitted upon this ballot, darken the oval to the left of the word "No."</p> <p>Explanatory statement. The purpose of this amendment is to provide the legislature with oversight of state executive branch agencies and officials by providing the legislature authority to establish procedures to revoke or suspend rules and regulations.</p> <p>A vote for this proposition would allow the legislature to establish procedures to revoke or suspend rules and regulations that are adopted by state executive branch agencies and officials that have the force and effect of law.</p> <p>A vote against this proposition would allow state executive branch agencies and officials to continue adopting rules and regulations that have the force and effect of law without any opportunity for the legislature to directly revoke or suspend such rules and regulations.</p> <p>Shall the following be adopted?</p> <p>§ 17. Legislative oversight of administrative rules and regulations.
