| <p><b>CONSTITUTIONAL AMENDMENT 1</b><br/>Vote Yes or No</p> <p>To vote in favor of any question submitted upon this ballot, darken the oval to the left of the word "Yes." To vote against any question submitted upon this ballot, darken the oval to the left of the word "No."</p> <p><b>Explanatory statement.</b> The purpose of this amendment is to provide the legislature with oversight of state executive branch agencies and officials by providing the legislature authority to establish procedures to revoke or suspend rules and regulations.</p> <p>A vote <b>for</b> this proposition would allow the legislature to establish procedures to revoke or suspend rules and regulations that are adopted by state executive branch agencies and officials that have the force and effect of law.</p> <p>A vote <b>against</b> this proposition would allow state executive branch agencies and officials to continue adopting rules and regulations that have the force and effect of law without any opportunity for the legislature to directly revoke or suspend such rules and regulations.</p> <p>Shall the following be adopted?</p> <p><b>§ 17.
