Dear Commissioners:

The Leavenworth County Development Corporation (LCDC) respectfully requests the Board's non-binding, exploratory support for submitting a potential site within Leavenworth County to be evaluated as part of the State of Kansas' ongoing discussions with TerraPower and Evergy regarding the possibility of locating a nuclear reactor within the state.

As the State of Kansas, Evergy, and TerraPower continue to examine potential locations for advanced energy projects, LCDC believes it is important for Leavenworth County to remain included in these conversations. Providing exploratory support at this preliminary stage does not commit the County to any future action or obligation. Instead, it preserves the opportunity to gain a deeper understanding of the technology, assess potential community and environmental impacts, and evaluate the economic and infrastructural benefits such a project may bring to our region.

LCDC sees significant value in ensuring the County has access to accurate information, meaningful dialogue, and a clear voice in the evaluation process as the State's review progresses. Offering non-binding support for site submittal simply enables Leavenworth County to continue exploring feasibility while maintaining complete autonomy over future decisions.

In addition to this request for exploratory support, LCDC respectfully asks that the Board consider and approve issuing a formal letter of interest addressed to the CEO of TerraPower (with a copy to the State of Kansas). This letter would solely serve to express the County's willingness to remain engaged in the evaluation process and to ensure Leavenworth County is afforded the opportunity to fully assess the feasibility and potential benefits of the project.

We stand ready to assist in preparing any materials needed for the Board's review and in coordinating communication with the relevant partners.

Thank you for your thoughtful attention to this matter and for your continued commitment to the long-term prosperity of Leavenworth County.

Action Requested: Approve request for Community Corrections to utilize Opiate Settlement Funding to maintain Cognitive Program Facilitator FTE established in 2023 through the use of these funds and utilize a portion of funds to meet matching requirements for the JMHCP BJA grant.

Recommendation: Approve request to utilize opiate settlement funds to sustain FTE to provide Cognitive Educational Programs and assist in warm hand-offs to recovery services to improve outcomes on probation for individuals struggling with Opioid Use Disorder (OUD) and co-occurring Substance Use Disorder (SUD) or mental health conditions and comply with matching fund requirements of the FY25 JMHCP BJA Grant.

Analysis: In FY25, Leavenworth County has received two Opiate Settlement Disbursements from MFAF totaling \$129,548.57. Community Corrections is requesting to utilize the funding to sustain our Adult Cognitive Behavioral Education Programs established in November of 2023. We are also requesting to utilize a portion of the funds to meet matching requirements of the federal JMHCP BJA grant awarded last fall. The funding requests are approved uses of the MFAF settlements and the current amount requested would cover the cost of the position and benefits for an additional year. We understand the lack of sustainability surrounding these funds and recognize the position may be temporary if opiate settlements discontinue. However, if the county receives additional funding we would continue to request those funds to sustain the position while also completing necessary annual reports to the AGs office on how our community is spending settlement funds on approved uses.
