2. All meeting dates are contingent upon complete submissions by the progressive deadline schedule. If any deadline is missed, the application WILL BE DELAYED.
3. Complete application submittal will be determined prior to the application being distributed for review. The applicant will be notified if the application is determined to be incomplete.
4. Incomplete or technically deficient plans may be returned without complete review.
5. All comments will be returned to the applicant within 10 businesses day of submittals and re-submittals of applications.
6. Applications that include a traffic study, innovative technology or other non-traditional systems may require additional review time.
7. During periods of unusually heavy submissions, review time may be extended.
8. All applications must have a pre-application meeting at least 5 days prior to submittal of application.
