**Procedure**

- Applicant to submit application including all required documents.
- Applicant to place flags at desired entrance location.
- Public Works must approve entrance location and size the entrance culvert.
- Planning & Zoning will notify applicant if entrance location is approved and specify the required culvert diameter.
- Applicant to notify Public Works (913-727-1800) after entrance is constructed for inspection.
- Public Works will refund \$100.00 after entrance has been constructed to County Standards.

The below signed has agreed to meet the specifications of the County Engineer for installation of an entrance culvert. The **ONLY** pipe that will be approved for installation will be a new corrugated steel galvanized pipe. **No concrete or masonry construction will be permitted within the road right-of-way.**

The undersigned hereby agrees to the conditions of this permit.

FEE: This permit shall have an associated fee of one-hundred and fifty dollars (\$150.00), and shall be either check or money order made out to: Leavenworth County Road and Bridge Fund. This is to ensure that an entrance is installed according to County Specifications.

BOND: \$100.00 is refundable upon completion to County standards. The \$50.00 administrative fee is non-refundable.

**IMPORTANT:** This permit expires one hundred twenty (120) days from date of issuance. If the entrance is not completed within 120 days, any temporary entrance or improperly installed entrance will be removed by Leavenworth County, and a roadway ditch cut at the entrance locations. Leavenworth County does not supply the culvert pipe for this entrance.

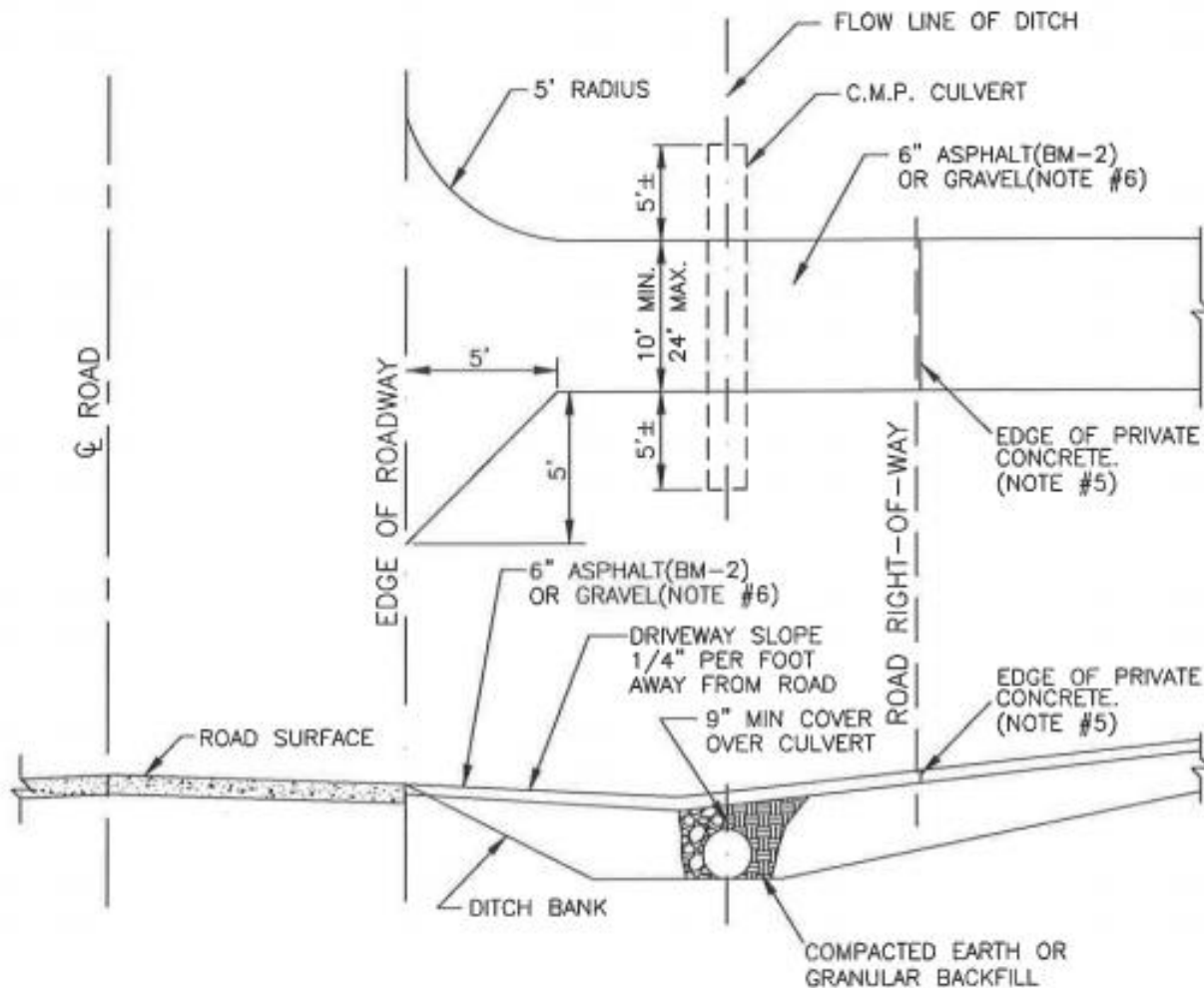

# RESIDENTIAL DRIVE ENTRANCE DETAIL FOR NON-CURB & GUTTER STREETS

## INSTALLATION NOTES:

1. CULVERT DIAMETER TO BE SIZED BY THE PUBLIC WORKS DEPARTMENT (15" MIN.)
2. MINIMUM LENGTH OF CULVERT IS TO BE 24' OR 10'+DRIVEWAY WIDTH
3. MANUFACTURED COUPLING BANDS ARE REQUIRED WITH C.M.P.
4. CULVERTS SHALL BE 16 Ga. C.M.P. WITH GALVANIZED OR ALUMINIZED COATING
5. CONCRETE DRIVEWAYS ARE NOT ALLOWED WITHIN THE PUBLIC ROAD RIGHT-OF-WAY
6. DRIVEWAY SURFACE SHALL BE EITHER 6" ASPHALT(BM-2) OR GRAVEL W/I R.O.W.



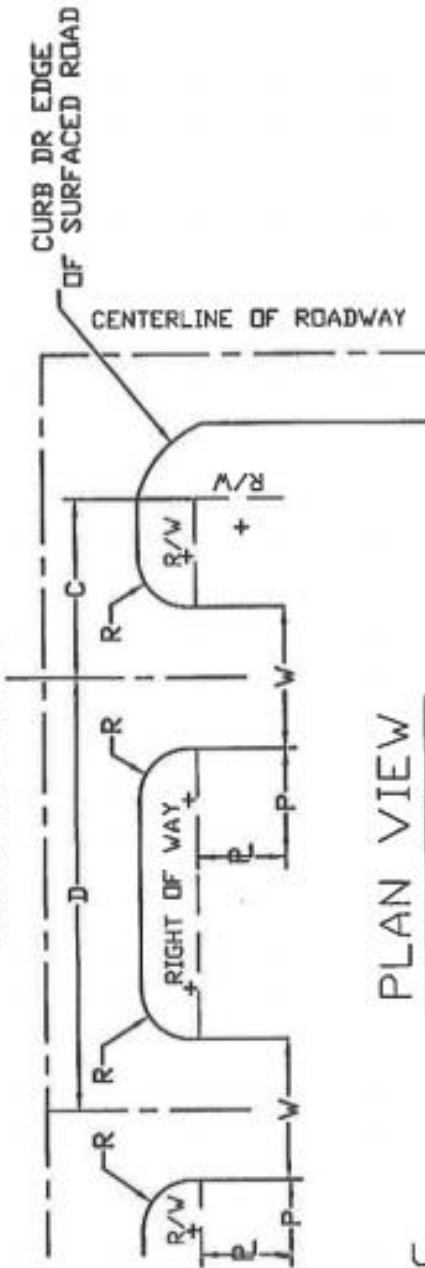
