

Counterfeit money, chicken wings, and rubber gloves result in prison sentence

LEAVENWORTH, Kan. --- A Leavenworth man who purchased chicken wings and breadsticks using a counterfeit \$100 bill has been sentenced to more than five years in prison.

On October 18, 2023, a judge sentenced Shawn M. Logan, 44, to 65 months in prison on 16 criminal charges and ordered him to pay restitution in the amount of \$20,741.11 to his victims.

Court documents detail Logan's crimes, which span from June 2020 to March 2023:

In June 2020, Logan entered a Leavenworth Little Ceasars Pizza and purchased chicken wings, breadsticks, and a drink using a counterfeit \$100 bill. During the investigation, a Secret Service agent verified the bill was counterfeit because there was no watermark. The agent also noted the ink was "running," and the Treasury seal was blurry. As a result of the investigation, Logan was charged with **counterfeiting currency**.

In April 2021, Logan stole a cutoff saw from a work truck parked on North Main Street in Lansing. Surveillance video from an area gas station helped identify Logan as a suspect. Logan would later be charged with **theft**.

Logan was charged with **theft** and **burglary of a motor vehicle** after stealing a Ford Ranger parked in downtown Leavenworth. After stealing the truck, Logan used it to take a refrigerator from another home in Leavenworth. Both crimes happened in December 2021.

Logan was charged with **burglary of a motor vehicle** following a June 12, 2022, incident where surveillance video captured Logan entering the parking lot of a service station on Metropolitan Avenue and stealing a pickup truck. Logan broke the truck's passenger side window by throwing small chunks of porcelain at the window.

Following an incident on July 23, 2022, Logan was charged with **theft** and **criminal damage to property**. Leavenworth police officers found a GMC truck disabled and parked in downtown Leavenworth. The truck's engine was still running, and a large amount of chain link fence and barbed wire was found wrapped around the front of the truck. Officers connected the fencing to damage located outside of a nearby business.

Crimes committed in October 2022 would result in Logan being charged with **two counts of burglary of a motor vehicle** and one count of **theft**. On October 8, Logan stole a Ford F350 from a business located in downtown Leavenworth. A cell phone found at the scene would later be identified as belonging to Logan. On October 9, Logan revisited the business' parking and stole property.

Logan was charged with **theft** and **burglary of a motor vehicle** following a November 12, 2022, theft of a Ford Edge SUV. On November 16, the Ford Edge was found unoccupied in downtown Leavenworth. A pair of rubber gloves found inside the vehicle were collected by investigators and tested. DNA on the rubber gloves would match Logan's DNA.

On December 24, 2022, Logan committed **theft** and **burglary of a motor vehicle**. Surveillance video from a grocery store on Eisenhower Road revealed Logan entered the grocery store and started small talk with a cashier. While engaged in small talk, Logan stole keys that were unintentionally left at the register by the victim. Logan then walked to the parking lot and stole the victim's Subaru Legacy.

Logan was charged with **burglary of a motor vehicle** and **theft** after stealing a Ford Ranger from the parking lot of a Leavenworth home improvement store. Court documents state the crimes happened on March 17, 2023.

Leavenworth County Attorney Todd Thompson said, "Although it took time, the investigation unfolded due to fingerprints and DNA analysis, which allowed law enforcement to connect all of these crimes." Thompson added, "Thanks to law enforcement, we've finally put an end to these serial burglaries that have greatly impacted our community."
