Instructions for Completing Waste Inventory Form

I. WASTE DESCRIPTION

- A. Describe, in as much detail as possible, the wastes you want to drop off at the collection site. Include the chemical and trade name, and MSDS, if available.
- B. Indicate the physical state of the waste: Solid (S) or Liquid (L).

II. GENERATION RATE

- A. Estimate maximum generation rate per month.
- B. Estimate maximum generation rate per year.

III. AMOUNT IN STORAGE

Estimate amount of hazardous waste currently accumulated by your business.

IV. DISPOSAL RATE

- A. Estimate amount of hazardous waste to be brought each time to collection site. You are limited to 55 lbs per month and no containers bigger than five gallons.
- B. Indicate desired frequency of disposal (weekly, monthly, annually, etc.),

V. CURRENT DISPOSAL METHOD

Indicate how hazardous waste is currently disposed of by your company.

## Hazardous Waste Generator Program Fee Schedule

Waste Category	Examples of typical waste	Cost
Latex Paint (3)(4)(5)	Interior, exterior, primer	\$1.00 per gallon can \$5.00 per 5 gallon bucket
Fuel Blending (5)(6)	Oil based paint, fuel, solvent based ink, thinners, paint strippers	\$.50 per pound
Dioxin and Dioxin Precursors	2,4,5-trichlorophenoxy-acetic acid and esters, 2,4-dichlorophenoxy-acetic acid and esters	\$3.00 per pound
Mercury	Elemental mercury or mercury salts	Varies, call for quote
Lab Pack	Corrosives	\$1.00 per pound
	Pesticides, Herbicides	\$3.00 per pound
	Oxidizers	\$2.00 per pound
	Aerosols	\$1.00 per can
	Flammable Solids	\$2.00 per pound
	Organic peroxides and reactive	Varies, call for quote
Light Bulbs	4ft & 8ft Florescent U-Shape & Circular	\$1.00 per light bulb
Large light bulbs	Metal Halide or Halogen	\$5.00 per light bulb

- (2) Per pound is gross weight
- (3) These categories are not counted for SQG generation rate
- (4) Container size no larger than 5 gallon
- (5) No more than 100 gallons accepted at a time of Non-Hazardous Waste
