## **FILING FEES OR FILING BY PETITION:**

### **Leavenworth City or Leavenworth Waterworks Board** **Three Council Seats**

\$20.00 Filing Fee

Leavenworth City Candidates must pay a \$50.00 Fee to Governmental Standards  
Waterworks Board does not have to pay the \$50.00 Fee to Governmental Standards  
Petition Filing: KSA 25-205 Ordinance No. 7987 - 50 qualified electors or not less than 1%  
of the ballots cast & counted at the last general city election, whichever is less.

4085 Ballots cast in November 2023 General Election  
41 Qualified Signatures Required

A first class city candidate (Leavenworth City Only) must appoint a treasurer.  
(Governmental Standards will mail the appointment form directly to  
Candidate's treasurer if needed.)

A primary election is required if the number of candidates who filed for an office is more than three times  
the number of positions to be filed. When, required, the purpose of the primary is to reduce the number of  
candidates at the general election to no more than two per position. (KSA 25-2021, 25-2108a)

\$20.00 Filing Fee

Petition Filing: KSA 25-205, Charter Ordinance No. 27 – at least 1%, or 10, of the qualified electors of the City of Tonganoxie, whichever is less.

10 qualified signatures required if filing by petition
