

RESOLUTION 2018- 25

RESOLUTION ESTABLISHING COMMISSION DISTRICTS FOR
LEAVENWORTH COUNTY. KANSAS

WHEREAS, the voters of Leavenworth County approved a change in the number of county commission districts from three (3) county commission districts to five (5) county commission districts at an election held November 6, 2018, under K.S.A. 19-204, and amendments thereto; and,

WHEREAS, the Board of County Commissioners of Leavenworth County, Kansas, per K.S.A. 19-204a, on or before January 1 immediately following such election, shall adopt a resolution dividing the county into five (5) county commission districts, as compact and equal in population as possible, and number them.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Leavenworth County, Kansas, hereby designate the following areas as the Commission Districts for 2019.

1. The **First District** shall consist of the following Townships in Leavenworth County, Kansas,
to-wit:
 Easton (including Easton City)
 Kickapoo

And in addition thereto, the following precincts of the City of Leavenworth, Leavenworth County, Kansas, to-wit: 1st Pct. 1st Ward, 1st Pct. 2nd Ward, 2nd Pct. 2nd Ward, 1st Pct. 3rd Ward, 1st Pct. 4th Ward, 1st Pct. 5th Ward, 2nd Pct. 5th Ward, 3rd Pct. 5th Ward, 4th Pct. 5th Ward and 1st Pct. 6th Ward.

Total Estimated Population of the First District: 15,351

2. The **Second District** shall consist of the following Townships in Leavenworth County, Kansas,
to-wit:
 Alexandria
 High Prairie

And in addition thereto, the following precincts of the City of Leavenworth, Leavenworth County, Kansas, to-wit: 2nd Pct. 6th Ward, 3rd Pct. 6th Ward, 4th Pct. 6th Ward, 5th Pct. 6th Ward, 2nd Pct. 7th Ward and 3rd Pct. 7th Ward.

Total Estimated Population of the Second District: 15,870

3. The **Third District** shall consist of the following Townships in Leavenworth County, Kansas, to-wit:

Fairmount (including the City of Basehor, Basehor Township Precinct and Glenwood Precinct.)

Stranger (including Stranger Precinct and Walnut Precinct)

Total Estimated Population of the Third District: 14,749

4. The **Fourth District** shall consist of the following Township in Leavenworth County, Kansas, to-wit:

Delaware

And in addition thereto, the following precincts of the City of Leavenworth, Leavenworth County, Kansas, to-wit: 3rd Pct. 2nd Ward and 1st Pct. 7th Ward.

And the following Wards of the City of Lansing, Leavenworth County, Kansas, to-wit: Ward 1, Ward 2, Ward 3 and Ward 4.

Total Estimated Population of the Fourth District: 14,143

5. The **Fifth District** shall consist of the following Townships in Leavenworth County, Kansas, to-wit:

Reno (including Reno East Precinct and Reno West Precinct)

Sherman (including the City of Linwood)

Tonganoxie (including Tonganoxie North Precinct and Tonganoxie South Precinct in the City of Tonganoxie and Tonganoxie Rural Precinct)

Total Estimated Population of the Fifth District: 12,373
