## RESOLUTION ESTABLISING COMMISSION DISTRICTS FOR

## LEAVENWORTH COUNTY, KANSAS

WHEREAS, the voters of Leavenworth County approved a change in the number of county commission districts from three (3) county commission districts to five (5) county commission districts at an election held November 6, 2018, under K.S.A. 19-204, and amendments thereto; and.

WHEREAS, the Board of County Commissioners of Leavenworth County, Kansas, per K.S.A. 19-204a, on or before January 1 immediately following such election, shall adopt a resolution dividing the county into five (5) county commission districts, as compact and equal in population as possible, and number them.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Leavenworth County, Kansas, hereby designate the following areas as the Commission Districts for 2019.

1. The **First District** shall consist of the following Townships in Leavenworth County, Kansas,

to-wit:

Easton (including Easton City) Kickapoo

And in addition thereto, the following precincts of the City of Leavenworth, Leavenworth County, Kansas, to-wit: 1<sup>st</sup> Pct. 1<sup>st</sup> Ward, 1<sup>st</sup> Pct. 2<sup>nd</sup> Ward, 2<sup>nd</sup> Pct. 2<sup>nd</sup> Ward, 1<sup>st</sup> Pct. 3<sup>rd</sup> Ward, 1<sup>st</sup> Pct. 5<sup>th</sup> Ward, 2<sup>nd</sup> Pct. 5<sup>th</sup> Ward, 3<sup>rd</sup> Pct. 5<sup>th</sup> Ward, 4<sup>th</sup> Pct. 5<sup>th</sup> Ward and 1<sup>st</sup> Pct. 6<sup>th</sup> Ward.

3. The **Third District** shall consist of the following Townships in Leavenworth County, Kansas, to-wit:

Fairmount (including the City of Basehor, Basehor Township Precinct and Glenwood Precinct.)

**Stranger (including Stranger Precinct and Walnut Precinct)**

4. The **Fourth District** shall consist of the following Township in Leavenworth County, Kansas, to-wit:

Delaware

And in addition thereto, the following precincts of the City of Leavenworth, Leavenworth County, Kansas, to-wit: 3<sup>rd</sup> Pct. 2<sup>nd</sup> Ward and 1<sup>st</sup> Pct. 7<sup>th</sup> Ward.

And the following Wards of the City of Lansing, Leavenworth County, Kansas, to-wit: Ward 1, Ward 2, Ward 3 and Ward 4.
