Dear Madam or Sir,

It is with great interest we are submitting our proposal for the Rock Crushing/ Quarry Operations for the Leavenworth County Public Works Department. Leavenworth Excavating & Equipment Co., Inc (LEXECO) is a local contractor that has been based in Leavenworth County for the last 70 years. I will outline below our quarry operations plan, estimate quantities, material, and pricing.

Part 1 Quarry Operations/Rock Crushing Plan:

LEXECO will develop a Storm Water Pollution Prevention Plan (SWPPP) and file it with KDHE. Once the SWPPP is complete and filed we will start stripping an area that is marked in exhibit A. We can be somewhat flexible in where we place the overburden. We can stockpile the overburden just to the north of the "mining" site, or we can place the overburden just to the southeast in the existing "mining" site. Once all the overburden is removed, we will have Buckley Powder come in and perform the blasting for the inplace fracturing of the rock. Once this is completed, we will set up the crusher as marked on the map in Exhibit B. We will then take the rock that has been blasted and stockpile it next to where the crusher will be set up. We will crush the rock into a rock that meets the KDOT AB-1 Spec. The rock will be stockpiled as marked in Exhibit B. Any Rock that does not meet the AB-1 Spec will be Stockpiled Separately.

Part 2 Estimated Quantities, and Unit Pricing and Payment Terms:

With the area we are estimating to strip we figured you could blast down 15'-16' deep and we would be able to crush around 150,000 tons of usable rock. Like stated above we would crush the rock to meet the KDOT AB-1 Spec. Any rock that does not meet that spec will be screened and stockpiled separately. LEXECO will provide a scale that is 25' long and 10' wide and provide the county with Rock Ticket books that the truck drivers will fill out their own ticket. Our conveyor belts that run off our crusher have scales on them that are calibrated so we will have a good idea of how much rock is stockpiled







compared to how much rock has been used. Every month the county will coordinate with LEXECO on how much rock they purchased, and they would be billed by the ton. If Leavenworth County wants to pay as they go the rock will be \$8.40 per ton. If Leavenworth County wants to pay as the rock comes off the belt it would be \$8.20 per ton. This would be billed monthly LEXECO would not set a scale up and the county would not have to weigh the trucks as they are loaded.
