THIS AGREEMENT is entered into as of the date of execution of the last signatory hereto, and is by and between Prime Healthcare Services – Saint John Leavenworth, LLC d/b/a Saint John Hospital and the Board of County Commissioners of Leavenworth County, Kansas (hereinafter referred to as "BOCC" or "Leavenworth County"). BOCC owns and operates the Ambulance Service for Leavenworth County (hereinafter referred to as "EMS").

WHEREAS, BOC, owns and operates the sole advanced life support ambulance service within Leavenworth County, Kansas.

WHEREAS, SJH operates a Hospital within the City of Leavenworth Kansas.

WHEREAS, SJH needs the services of an ALS ambulance to transport inpatients from the Emergency Room to the Main Hospital Building.

NOW, THEREFORE, IN CONSIDERATION THEREOF, SJH and BOCC mutually agree as follows:

- 1. <u>Services</u>. BOCC will provide on-campus transportation services from the SJH ER to the main hospital building for patients being admitted.
- 2. <u>Compensation</u>. SJH agrees to compensate EMS for such Transports at the agreed attachment "A" Rates that may be renegotiated time to time and agreed upon.
- 3. <u>Term.</u> This Agreement shall become effective upon the date of execution by the last party to execute the agreement. This agreement shall remain in effect until terminated as provided for herein.

4. Termination.

- (a) <u>Termination Without Cause</u>. Either party may terminate this Agreement at any time without cause by giving the other party at least 30 days' prior written notice of such termination (a "Without Cause Notice of Termination").
- (b) <u>Termination for Breach</u>: Either party may terminate this Agreement upon breach by the other party of any material provision of this Agreement, *provided* that, to effect such termination, the non-breaching party must give the breaching party at least 15 days' prior written notice of the termination (a "Breach Notice of Termination") and describe in such notice the breach claimed by the terminating party.

- (c) <u>Immediate Termination</u>. Either party may terminate this Agreement immediately by written notice to the other party (an "Immediate Notice of Termination") upon the occurrence of any of the following events:
- (1) The other party's license in the State lapses or is denied, suspended, revoked, terminated, relinquished or made subject to terms of probation or other restriction;
- (2) The other party is excluded or otherwise declared ineligible to participate in, or barred or suspended from, Medicare, Medicaid or any other federal health care program, or is convicted of an offense related to health care; or
- (3) The other party closes or ceases patient care operations to such an extent that patient care cannot be carried out adequately.
- (d) Effective Date of Termination; Opportunity to Cure. The effective date of termination of this Agreement shall be (i) in the case of a termination pursuant to Section 4(a), the date of termination specified in the Without Cause Notice of Termination, provided that such date shall not be less than 30 days after the date such Without Cause Notice of Termination is given, (ii) in the case of a termination pursuant to Section 4(b), the date of termination specified in the Breach Notice of Termination, provided such date shall not be less than 15 days after the date such Breach Notice of Termination is given, and (iii) in the case of a termination pursuant to Section 4(c), the date on which the Immediate Notice of Termination is given. If a party terminates this Agreement pursuant to either Section 4(a) or Section 4(c), the other party shall have no rights to cure or contest the termination of this Agreement. If a party terminates this Agreement pursuant to Section 4(b), the other party shall have the right to cure the breach described in the Breach Notice of Termination prior to the effective date of termination set forth in such notice, provided that, if the breach is not cured during such period, this Agreement shall automatically terminate on the date of termination set forth in the Breach Notice of Termination.
- (e) <u>Effect of Termination</u>. As of the effective date of termination of this Agreement, neither party shall have any further rights or obligations hereunder except for rights and obligations accruing prior to such effective date of termination, or arising as a result of any breach of this Agreement. Notwithstanding the foregoing, the following provisions of this Agreement shall survive the expiration or termination of this Agreement, regardless of the reason of such termination: Sections 4, 6, 7, 8, and 12.
- 5. <u>Independent Contractors</u>. This Agreement does not and shall not be construed to create any principal/agent, master/servant, and employer/employee or partnership relationship of any kind between SJH and BOCC. Neither party shall have any rights by reason of participation in this agreement for any salary remuneration or compensation, or any employment benefits, Social Security, Worker's Compensation coverage, disability or unemployment insurance benefits, vacation pay, sick leave, nor any other remuneration of any kind whatsoever.

- 11. Governing Law and Venue. This Agreement shall be construed in accordance with the laws of the State of Kansas and jurisdiction and venue of any suit in connection with this agreement shall reside only in a court located in Leavenworth, Kansas The provisions of this Section shall survive expiration or termination of this Agreement regardless of the cause of such termination.
- 12. <u>Counterparts</u>. This Agreement may be executed in one or more counterparts, all of which together shall constitute only one Agreement or to such other persons or places as either party may from time to time designate by written notice to the other.
- 13. <u>Waiver</u>. A waiver by either party of a breach or failure to perform hereunder shall not constitute a waiver of any subsequent breach or failure.
- 14. <u>Compliance with Laws</u>. The Parties agree that they shall comply with all applicable local, state, and federal laws and regulations in carrying out this Agreement, regardless of whether those legal requirements are specifically referenced in this Agreement and will not violate the Anti-Kickback Statute and the Stark Law with respect to the performance of the Agreement.
- 15. Anti-Discrimination Clause. SJH agrees to (a) to comply with the Kansas Act Against Discrimination (K.S.A. 44-1001 et seq.) and the Kansas Age Discrimination in Employment Act (K.S.A. 44-1111 et seq.) and the applicable provisions of the Americans With Disabilities Act (42 U.S.C. 12101 et seq.) (ADA), and Kansas Executive Order No. 19-02, and to not discriminate against any person because of race, color, gender, sexual orientation, gender identity or expression, religion, national origin, ancestry, age, military or veteran status, disability status, marital or family status, genetic information, or political affiliation that is unrelated to the person's ability to reasonably perform the duties of a particular job or position; (b) to include in all solicitations or advertisements for employees, the phrase "equal opportunity employer"; (c) to comply with the reporting requirements set out at K.S.A. 44-1031 and K.S.A. 44-1116; (d) to include those provisions in every subcontract or purchase order so that they are binding upon such subcontractor or vendor; (e) that a failure to comply with the reporting requirements of (c) above or if the contractor is found guilty of any violation of such acts by the Kansas Human Rights Commission, such violation shall constitute a breach of contract and the agreement may be cancelled, terminated or suspended, in whole or in part, by the BOCC; (f) if it is determined that SJH has violated applicable provisions of ADA, such violation shall constitute a breach of contract and the agreement may be cancelled, terminated or suspended, in whole or in part, by the BOCC. SJH agrees to comply with all applicable state and federal anti-discrimination laws.

- 6. Responsibility; Insurance. To the extent permitted by law and without waving any of the immunities set out in K.S.A. 75-6101 et seq., the parties shall each be responsible for their own acts and omissions in the performance of their duties hereunder, and the acts and omissions of each party's own employees and agents. Both Parties hereto agree to maintain comprehensive general liability coverage in the amount of One Million Dollars (\$1,000,000.00) per occurrence. In addition, BOCC shall maintain commercial automobile coverage with a combined single limit of One Million Dollars (\$1,000,000.00) per occurrence. Both Parties agree to provide coverage to the other upon request.
- Assignment. Neither party may assign or transfer this Agreement in whole or in part, or assign or delegate any of party's rights, duties or obligations under this Agreement, in each case without the prior written consent of the other party, and any assignment, transfer or delegation by the party without such consent shall be null and void. Notwithstanding the foregoing, either party may assign this Agreement, in whole but not in part, without the consent of (but with prior notice to) the other party in connection with the sale of all of substantially all of the assets constituting the party. This Agreement shall inure to the benefit of and be binding upon the parties hereto and their respective heirs, representatives, successors and permitted assigns.
- 8. Severability. If any clause or provision of this Agreement is illegal, invalid, or unenforceable under the present or future laws effective during the term of this Agreement, then and in the event, it is the intention of the parties hereto that the remainder of this Agreement shall not be affected thereby and it is also the intention of the parties to this Agreement that in lieu of each clause or provision of this Agreement that is illegal, invalid or unenforceable, that will be added as a part of this Agreement a clause or provision as similar in terms to such illegal, invalid, or unenforceable clause or provision as may be possible and be legal valid and enforceable.
- 9. <u>Disputes</u>. In the event that there is any question regarding the interpretation or implementation of this Agreement, the parties agree to form a joint committee of three persons from each party, who shall meet and attempt to reach a mutually satisfactory resolution of the issue with three business days of a request by either party for such meeting.
- 10. <u>Entire Agreement; Modification</u>. This Agreement contains the entire understanding of the parties with respect to the subject matter hereof and supersedes all prior agreements, oral or written, and all other communications between the parties relating to such subject matter. This Agreement may not be amended or modified except by mutual written agreement. Any reference to this Agreement shall include each and every exhibit, each of which is fully incorporated into this Agreement where referenced.

This policy would put in place some guidelines on what type of requests would be considered and implement some checks and balances follow up.

STATEMENT:

The County Commission often receives requests for financial assistance from entities that do not operate under a county department nor are they governmental. These entities often provide services outside the normal scope of County government but are vital to the quality of life to county residents. While these entities offer value and provide services not already covered by governmental services, County resources are limited and tax dollars must be used in a financially responsible manner.

Therefore, the BOCC wishes to implement the following policy. Any current policy or practice in place that would be in conflict with this policy is repealed.

POLICY:

Request for funds will only be considered if they do not affect the ability of the County to fund County departmental operations or result in a mill levy increase. Applying does not guarantee funding. Likewise receiving funding in one year does not indicate a commitment to future contributions.

In order to be eligible to receive funding an agency must provide a request for funding prior to June 15th of the year prior to the funds being dispersed. The request must include the amount requested, the intended use of funds, a copy of the organization's annual budget with financials showing available funds, all sources of revenue and planned expenses. The following general guidelines are used to review the qualifications of applications.

- Only non-profit agencies that are be able to demonstrate that the services they provide are equally available to all Leavenworth County citizens will be eligible for funding.
 - o Documentation of non-profit status must be included with the application.
- County funds will only be provided to organizations that do their banking in Leavenworth County.
- Any agency that the County is the largest single donor or provides more than 30% of their total revenue must reserve a spot on their executive committee for a County appointed member.
- Funding requests for general operating budgets will be limited to strategic community partners.
 - The agency must provide the most recently completed audit.
- Funding requests from all other organizations will be limited to capital projects or onetime special projects.
 - o If funds are awarded for capital projects distributions in excess of \$5,000.00 will only be made when invoices for completed work are submitted.
 - Funds provided by the County cannot exceed 50% of the project cost.
 - The balance of the funds needed for the project must already be available.
 - The County will not contribute ad valorem funds to any entity that has the capability to levy its own taxes. This ensures county tax payers are not funding services they receive no benefit from.

Any agency that previously received County funds must provide documentation that the funds were utilized for what they were requested for.

Action Requested: Formal board action to allow the Public Works Department to accept 178 th Street and Stillwell Road based upon the receipt and acceptance of the materials test for the corrective actions taken and issuance of a 2-year maintenance bond.
Recommendation: Approval
Analysis: For the past two years the Public Works Department has been working with McCown-Gordon and KTI (inspection firm) to sift through all of the projects testing and inspection documents to be able to document the necessary steps were taken to build the new roads to the school to a county standard. The State of Kansas awarded the project a Kansas Cost Share Grant and KDOT has accepted their portion of the roadway improvements. The attached document demonstrates the testing frequencies that were not found or completed for the roadway.
During the road acceptance review County and Olsson staff found that two culverts were crushed during installation. Those two culverts have been replaced and testing was completed to county requirements for those locations. Public Works is awaiting the delivery of the testing results.
The road has been used by the school for the past year and does not have signs of failure. McCown-Gordon has offered to provide the county a 2-year maintenance bond instead of the required one year bond. Effectively, this would cover the cost of any failures the roadways for the first 3 years of usage.
There has been a 46 Lot subdivision that has been on hold, from my understanding, for the past year waiting for the contractor to correct these issues.

Dear Mr. Noll,

As part of the Basehor-Linwood School project roadway improvements to 178th Street and Stillwell Road were constructed. It is Olsson's understanding the project construction activities are complete. Per Leavenworth County Public Works requirements all necessary testing during construction was to be performed per KDOT Specifications and Testing Frequencies (current edition). At the request of Public Works, Olsson was asked to review the project testing procedures, frequencies, and results from the documentation provided by the contractor and testing agency for both roads against KDOT's testing frequency chart for Non-Quality control/Quality Assurance Specifications. Of the testing that was performed it was determined that those results met KDOT specifications. However, Olsson did identify deficiencies in completing all of the testing as required by KDOT, below is a list of said deficiencies:

178th Street

- 1. Density testing completed on fill placement on approximately 5' of fill placement from 6/15/21 to 6/22/21. KDOT requires 4 tests per day per lift. Project testing conducted 3 tests per day per lift.
- Density testing was completed on the cement treatment of the subgrade on 7/8/21.
 KDOT required density testing was completed, but KT-42 Sieve analysis for acceptance of cement-treated soils was not completed.
- 3. Density testing on the aggregate base course was completed on 7/30/21. KDOT required density testing was completed, but KT-2 Sieve Analysis of Aggregate and KT-10 Plasticity Tests were not conducted.
- 4. Density testing was completed on the asphalt base course on 6/20/22. KDOT required density testing was completed, but no KDOT laboratory testing of the hot-mix asphalt or individual aggregate was completed.
- 5. Density testing was completed on the asphalt surface course on 7/26/22. KDOT required density testing was completed, but no KDOT laboratory testing of the hot-mix asphalt or individual aggregate was completed.
- 6. Required proof rolls were not taken to check subgrade stability prior to the placement of asphalt.

Stillwell Road

- Density testing was completed on the backfill of the stormwater line under Stillwell at Sta. 16+45. KDOT required density testing was completed by the testing agency.
- Density testing was completed on the cement treatment of the subgrade on 3/17/22.
 KDOT required density testing was completed, but KT-42 Sieve analysis for acceptance of cement-treated soils was not completed.
- Density testing on the aggregate base course was completed on 4/1/22 and 4/5/22.
 KDOT required density testing was completed, but KT-2 Sieve Analysis of Aggregate and KT-10 Plasticity Tests were not completed.
- 4. Density testing on the backfill of the waterline crossing under Stillwell Road just west of K32 on 4/27/23. KDOT required density testing was completed by the testing agency.
- 5. Density testing was completed on the asphalt base course on 6/20/22. KDOT required density testing was completed, but no KDOT laboratory testing of the hot-mix asphalt or individual aggregate was completed.
- 6. Density testing was completed on the asphalt surface course on 7/26/22. KDOT required density testing was completed, but no KDOT laboratory testing of the hot-mix asphalt or individual aggregate was completed.
- 7. Required proof rolls were not taken to check subgrade stability prior to the placement of asphalt.

178th Street & Stillwell Road/Storm Condition Photos

<u>Culvert Condition:</u> The following photos identify the current condition of the Stillwell Road and 178th Street stub road improvements associated with the USD #458 Basehor Linwood School South Project site located at 14440 178th Street, Bonner Springs, KS. The project was constructed in 2021/2022. The initial two photos show damaged crossroad culverts on Stillwell Road. Damage occurred during the roadway construction.



Figure 1: Crushed 24" CMP Crossroad Culvert on Stillwell Road, east of 178th Street

Damage of the pipe is located on the upstream segment of the culvert. Damage to the second culvert is less severe, but also occurred during the roadway construction. Damage location is approximately midway through the culvert length and difficult to see in the photo. The damage is an approximate 3" crush of the top line of the culvert.



Figure 2: 24" CMP Crossroad Culvert at the intersection of K-32 Highway and Stillwell Road

<u>Roadway Condition:</u> Roadway segment appeared to be structurally sound for both Stllwell Road and 178th Street segments. There was a significantly higher amount of segregation in the asphalt surface course than would typically be expected but the roadway is holding up. Example photo of segregation area is shown below. All other components of roadway appear normal.

A Prioritization Plan for Transportation Capital Improvement Projects

What is "Priorities for Progress"?

The Leavenworth County Region, including the cities of Basehor, Lansing, Leavenworth, and Tonganoxie, along with the County of Leavenworth and the Leavenworth County Port Authority (LCPA), in cooperation with MARC and KDOT, is working to prioritize transportation investments in the coming years. Over the past few decades, there have been numerous studies on transportation infrastructure in and around the Leavenworth County region. These studies have focused on projects that range from modest investments to grand visions of new freeways and river crossings. With these wideranging studies, however, comes the question: what projects do the leaders, stakeholders and general public in the region want to prioritize to seek regional, state or federal funding? This prioritization plan seeks to best position the communities within Leavenworth County - rural and municipal - to compete for and obtain funding to advance transportation projects. The plan has been branded as Priorities for Progress: Connecting Community Opportunities ("P4P").

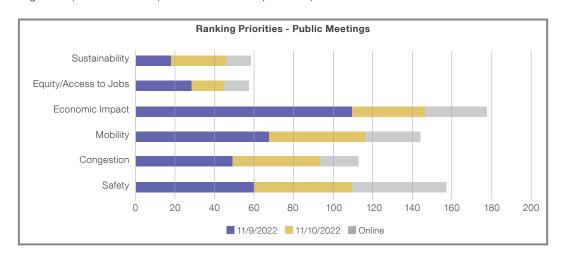
Targeted Funding Sources

Typically, large transportation infrastructure projects are designed and constructed using a variety of external funding sources — competitive processes in which projects from Leavenworth County would be competing against projects from other counties, regions, or states to obtain funding. The project team coordinated with MARC, KDOT, Leavenworth County, and the local jurisdictions to establish criteria for evaluating the projects shown on the map on the back page. These projects were identified by compiling and reviewing nearly 30 planning documents and studies that have been conducted since 2000, as well as an iterative feedback process from stakeholders and the general public. Targeted funding sources and example projects are shown in the table below.

Stakeholder and Public Engagement

This planning effort featured an extensive county-wide engagement effort intended to gather refreshed information from the public about their interests, concerns and ideas; learn by processing public input and trends into a concrete criteria and prioritization process; and create a vision by unveiling a recommended capital improvement project prioritization. Ultimately, the feedback the stakeholder and public engagement process was used to identify new projects, screen out other projects, and refine the scope of several projects initially identified. The priorities of the general public – as compiled across two in-person open houses and an online forum – are shown below.



Identified Transportation Projects and Project Evaluations

Following the stakeholder and public engagement process in Fall 2022, the map to the left summarizes the projects that were ultimately carried forward and recommended for further study and evaluation as part of the P4P effort. Each project was evaluated across more than 30 potential metrics and scored across eight unique categories. More details about each of these projects is provided in the P4P full plan.

Recommended Priorities for Specific Funding Sources

It is recommended that the City Councils of Tonganoxie, Basehor, Lansing, and Leavenworth, along with the Leavenworth County Commission, adopt resolutions of support for this study's findings and the initial prioritization of projects for the different funding sources.

For **KDOT's IKE Program**, which is anticipated to be soliciting projects through the Local Consult process later in 2023, it is recommended that the following projects be submitted for consideration:

- > K-5 Improvements/Realignment
- K-7 Combined Interchanges (or individual interchanges)
- Leavenworth City Western Bypass
- West K-10 Connection (West Kansas River Crossing) and the West Tonganoxie Bypass (US 24/40 to K-32)
- Eastern Gateway (at this stage, this project should be submitted for the Project Development pipeline to utilize KDOT funding as a match for the RAISE grant discussed below).

For the **USDOT Competitive Grants**, which are solicited annually, it is recommended that the following projects be submitted for consideration:

- The Eastern Gateway project should be submitted for a planning study through the RAISE grant program. This project would require support from KDOT, MoDOT, MARC, and active legislative support from U.S. Representatives and Senators.
- The cities of Tonganoxie, Basehor, and Lansing should submit for the SS4A Planning and Demonstration grants.
- Once agencies have established formal safety
 Action Plans, they should seek to apply for SS4A
 Implementation grants for specific intersection
 or corridor projects. For Leavenworth County,
 one notable project would be packaging together
 various safety improvements along the Tonganoxie
 – Eisenhower corridor as a corridor-level project.

For **MARC's STBG and STBG Set-Aside Program**, which is anticipated to have a call for projects in 2024, it is recommended that the following projects be submitted for consideration:

- > K-5 Improvements/Realignment
- > 158th/155th Street Corridor (not including the interchange with 158th Street and I-70, which must be funded by the Kansas Turnpike Authority or local funds)
- > Parallel Road Widening note that it is recommended to reframe this project as "improvements," as this project includes much-needed bicycle and pedestrian facilities, as well as intersection safety improvements.
- Tonganoxie Eisenhower Corridor Improvements
- > Focused Demand-Response Transit Service in Leavenworth-Lansing

For **MARC's PSP Program**, which is anticipated to have a call for projects in 2024, it is recommended that the following projects be submitted for planning work that will better position them for STBG funding in subsequent years:

- Combining the 158th Street (north of Basehor) and 20th Street Extension / McIntyre Road extension projects into a study of how to enhance connectivity among Basehor, Lansing, and Leavenworth west of K-7, with a focus on connecting underserved populations with bicycle and pedestrian accommodations, accommodating future transit, and integration with the regional MetroGreen Trail network.
- Conducting a "Kansas River Crossing Study" to explore upgrades to existing crossings south from Leavenworth County or the creation of a new crossing, with a focus on connecting underserved populations to new job centers south of the river, providing a bike/ped crossing of the river (neither existing bridge crossing has accommodations), and opening up access to parks and recreation.







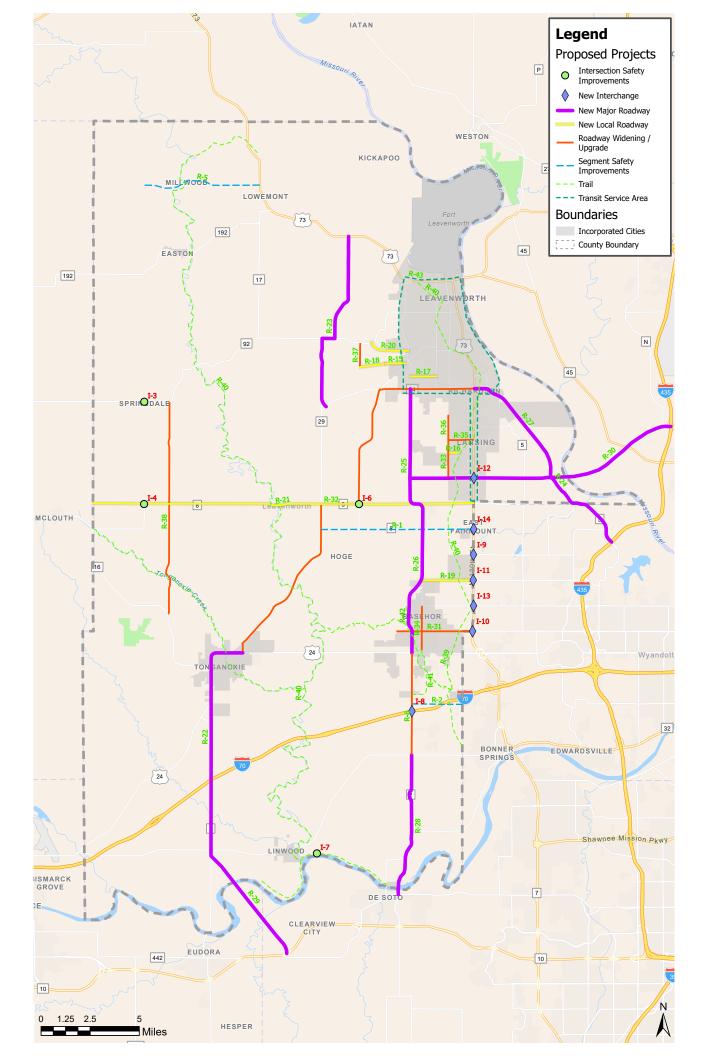

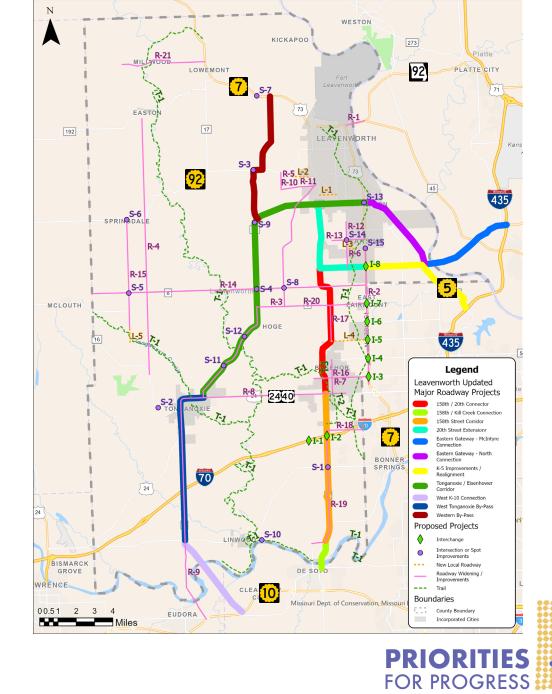

 - Focus on connecting underserved populations to new job centers south of Kansas River
 - Recommend partnering with Johnson County and/or De Soto





Conclusion

- This project had extensive public, stakeholder and elected official outreach
 - 43 Projects were identified through that outreach
- The projects were evaluated based on defined metrics, aligning with scoring criteria from different funding sources and outreach
- The community can now speak with one voice to advocate projects – bringing a stronger position with multi-jurisdictional support
 - KDOT's Local Consult is scheduled for October 17 in Lenexa

A RESOLUTION TO ACCEPT THE PROGRESS FOR PRIORITIES REGIONAL TRANSPORATION CAPTIAL IMPROVEMENTS PLAN CONDUCTED JOINTLY BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF LEAVENWORTH, KANSAS AND THE CITIES OF BASEHOR, LANSING, LEAVENWORTH, AND TONGANOXIE, KANSAS

WHEREAS, the Partners recognize that collective support among the Partners will improve the positioning of projects to be awarded through the competitive grants offered through MARC, KDOT, and the U.S. Department of Transportation; and

WHEREAS, the Partners retained the services of Kimley-Horn and Associates, Inc. ("Kimley-Horn") to conduct a transportation capital improvement plan to identify and prioritize transportation improvements within the Leavenworth County Region; and

WHEREAS, Kimley-Horn has completed the transportation capital improvement plan through an analytical evaluation of the impact of various transportation projects considering the priorities of various funding agencies and the public, herein referenced as the Priorities for Progress report dated ______, 2023, the terms and results of which are incorporated herein by this reference.

NOW THEREFORE BE IT RESOLVED BY THE GOVERNING BODIES OF THE COUNTY OF LEAVENWORTH, THE CITY OF BASEHOR, THE CITY OF LANSING, THE CITY OF LEAVENWORTH, AND THE CITY OF TONGANOXIE TO ACCEPT THE FINDINGS OF THE PROJECT PIORITIES FOR PROGRESS REPORT AND THE PROJECT PIORITIES LISTED WITHIN.
