Military Plates

These plates are available to anyone who is currently or has been a member of the armed forces, and owns or leases an automobile or truck with a gross weight of 20,000 pounds or less. See each plate type for additional documents that will be required. If the vehicle is currently tagged, the applicant must return their original plate, provide current owner's registration, and proof of insurance. All fees stated are for the plate. In addition, Registration, Title, Property Tax and Sales Tax Fees may apply.

Also eligible, NO MORE THAN TWO of the following decals: Silver Star, Bronze Star, Combat Medical Badge, Combat Infantry Badge, Navy/Marine Corps Combat Action Ribbon, Army Distinguished Service Cross, Navy Cross, Air

Force Cross, or Distinguished Flying Cross. Branch of Service decals also available.

Former prisoner of war or surviving spouse of former prisoner of war is eligible for one license plate; \$5.50 for issuance, decals \$2.00 each. First time issuance: Form TR-120 and DD214 showing Prisoner of War required. If surviving spouse, must provide proof of marriage with marriage license or POW DD214.
